Hugo Sinzheimer Moot Court Competition

The aim of the HS MCC is to deepen and improve the knowledge of employment and labour law at the European level. It offers students an opportunity to experience European law in a setting that is as realistic as possible.

Every year, this event is hosted in another country. The first HS MCC took place in June 2016 and was hosted by the Hugo Sinzheimer Institute in Amsterdam, the Netherlands. After Aarhus University (Denmark, 2017) and the University of Cassino (Italy, 2018), the competition's fourth edition was hosted by Hasselt University (Belgium, 2019). Fifth – 2020 edition of the competition was planned to be hosted by Ilia State University (Georgia), but the event was cancelled due to developments around Covid-19 pandemic. After receiving requests from some participants, the organizing committee and Ilia State University agreed to organize an online (light) edition of the Hugo Moot with 6 teams participating. The competition's fifth full (traditional) edition with all 13 participating teams is organized online, hosted by Ilia State University. So from 17 until 19 June, 2021, approximately 100 ambitious people will be gathering online in "Georgian court rooms" for the fifth full edition of the Hugo Sinzheimer Moot Court Competition (HS MCC).



About Hugo Sinzheimer

The competition is named after the German scholar and lawyer Hugo Sinzheimer (1875-1945), who is internationally considered the founding father of labour law. His ideas and publications have had a profound impact. Sinzheimer, who united various perspectives on labour law, stands for the concept of Social Labour Law.

Sinzheimer, who held a PhD in Law and Economics from the University of Heidelberg, later became an honorary professor of Labour Law and Sociology of Law at the University of Frankfurt in 1933. Being Jewish, Sinzheimer was forced to flee to the Netherlands. He immediately obtained a professorship in Sociology of Law at the University of Amsterdam, which in 1936 was followed by a second professorship in Leiden.

As a member of the Weimar National Assembly, Sinzheimer was also actively involved in the construction of the Weimar Constitution, which contained rights regarding freedom of association and employee participation.

From 1993 onwards, the Hugo Sinzheimer Institute of the University of Amsterdam has been named after this great lawyer. In 2010, a Hugo Sinzheimer Institut für Arbeitsrecht was also founded in Frankfurt am Main, Germany. The Hugo Sinzheimer Moot Court Competition is institutionally embedded within the Hugo Sinzheimer Institute at the Law School of the University of Amsterdam.

Ilia State University was founded in 2006 as a result of a merger of six different academic institutions with long and varied histories. Currently, it is one of the leading research and educational institutions in Georgia. Representing a union of students and professors, ISU is a multifunctional educational and research institution offering a common space for academic and professional education and research with the joint efforts of its students, professors, teachers and researchers.

The union is based on the three following principles:

- ACADEMIC FREEDOM
- FREEDOM OF CONSCIENCE
- FREEDOM OF CHOICE



School of Law

Ilia State University Law School is a well-known center of legal education in Georgia. It is represented by an outstanding and diverse faculty who combine strong academic and practical backgrounds. Capital City - Tbilisi

Tbilisi was founded in the 5th century AD. and has attracted visitors ever since, drawn by the hot springs for which the city is named, by the lively atmosphere of its cobbled streets and caravanserais, or simply by what Alexandre Dumas called the "strange, fascinating charm" of this "city of legend and romance."

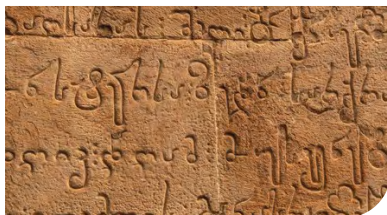
Georgia May Be Home to One of the Oldest Communities

An archaeological expedition to a site in Dmanisi found the oldest human skulls – some up to 1.8m years old – in the Caucasus, providing evidence that Georgia may be home to one of the oldest communities. Though six skulls were found, two have been given the Georgian names Zezva and Mzia and artists have worked to reconstruct their likeness.



Unique Language and Script

Spoken by less than 5 million people worldwide, Georgian language has an ancient literary tradition. Georgian alphabet was created in the 3rd century BC and developed three distinct writing systems, all of which are in use today. This phenomenon has been recognised by UNESCO and included in the list of Intangible Cultural Heritage.



Cradle of Wine

One of Georgia's claim to fame is that this is the land where, according to the latest archaeological evidence, 8000 years ago a vine plant was domesticated and wine was made. It's no wonder that wine and winemaking are deeply entrenched in Georgian psyche, culture and tradition. Making wine in 'kvevri' – a clay vessel dug in the ground – is a uniquely Georgian tradition recognized as UNESCO's Intangible Cultural Heritage.



Delicious Cuisine

The country's diverse landscape and climate combined with the presence of cultural influences from the West as well as from the East produced culinary tradition which is rich, varied, and unique in its own right. When travelling through various regions one encounters distinct flavours and local dishes specific to the area. This human cultural diversity manifested not just in culinary tradition, is still present in Georgia, and is still holding up and resisting steadily advancing cultural homogenisation. There are culinary delights awaiting every palate and taste embellished by locally produced distinct wines.



Georgian Folklore

Be witness to the hovering men and women, unique steps, and dizzying dance moves, that tell stories of war, love, and friendship - your introduction to Georgian dances! Captivated spectators are left breathless watching the stunning performances and call for an encore with thunderous applause. The magical sensation fills the theater (or: there's magic in the air), uniting thus, spectators and dancers into participants in this one big celebration. These dances performed today have been enacted for centuries. Georgian folk songs are also incredibly melodic. Stories are narrated through music. As a matter of fact, Georgian polyphonic singing has been proclaimed by UNESCO Intangible Cultural Heritage. In 1977 "Chakrulo", a Georgian folk song, was included in the Golden Records sent into space on the Voyager.

Meet the Jury-Judges



Stefan Koeck (Austria)

Member of the Case Committee

Dr. Stefan Koeck is teaching employment and social security law at the University of Vienna and practices law, mostly employment law, in Vienna, Austria. He has studied law at the University of Vienna (Mag. jur and Dr. jur) and at Northwestern University School of Law (LL.M.) and, after an initial career as a teaching assistant at the University of Vienna, has worked in private practice in Vienna

and Brussels for almost 30 years, of which 20 years as partner of Freshfields Bruckhaus Deringer, with a focus on employment and corporate law. A former Board member of the European Employment Lawyers Association, he is now editor-in-chief of Austrian employment law journal Zeitschrift für Arbeitsrecht und Sozialrecht. His work focusses on issues of collective labour law, executive employment and on the impact of European Union legislation on Austrian employment law. His new commentary on the Austrian Code of Procedure in Labour and Social Security matters has been published recently.



Benedikt Sprinzl (Austria)

Member of the Case Committee

Benedikt Sprinzl is a senior associate in the People and Reward team of Freshfields Bruckhaus Deringer and works in the Vienna office. He has studied business law and business administration at the WU Vienna University of Economics and Business. He advises clients on all aspects of individual and collective employment law, company pensions,

employment issues in M&A and restructuring projects and he represents clients in court on employment matters.

Felicia Kain (Austria)

Member of the Case Committee

Felicia Kain is a teaching and research associate at the Institute for Austrian and European Labour Law and Social Security Law at the Vienna University of Economics and Business, Austria. She is the author of several publications about Austrian, European as well as international labour law and law of social security. Felicia is currently pursuing a PhD in this very field. She was a visiting researcher at

the UZH Zurich, where she examined the coordination of family benefits between Switzerland and the EU Member States. Starting in September 2021, she will be a research associate at the Supreme Court in Vienna. Felicia was herself a participant in the Hugo Sinzheimer Moot Court Competition 2018 in Cassino, where her team won third place and the award "excellent written statement."



Thomas Pfalz (Austria)

Member of the Case Committee

Dr. Thomas Pfalz is a senior scientist at the Institute of Law at University of Klagenfurt. After starting his career in a law firm, Thomas Pfalz joined University of Vienna (Institute for Labour and Social Security Law) as a teaching and research associate in 2013. In 2017 he finished his PhD with a thesis on unemployment insurance for self-employed persons. 2018 he joined University of Klagenfurt where he

is currently pursuing his habilitation project. Recent topics of research include payment transparency, competition clauses and the transfer of undertakings. As a student Thomas Pfalz took part in an international Roman Law Moot Court in Philippi (GRE) in 2010.



Manfred Weiss (Germany)

Member of the Advisory Board

Manfred Weiss is the Professor emeritus of labour law and civil law at Goethe University in Frankfurt and has inter alia been President of the International Industrial Relations Association (IIRA - currently ILERA), consultant to the ILO and consultant to the Commission of the EU. He is an honorary professor of the University of Cape Town as well as an extraordinary professor of NWU, University of

Stellenbosch and UWC. He is the author of numerous books and articles in the field of labour law, European labour law, and industrial relations. In 2015, he received the LLRN-Award for outstanding contributions to labour law.



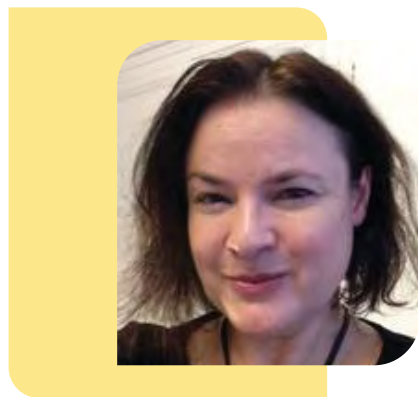
Jean-Michel Servais (Switzerland)

Member of the Advisory Board

Jean-Michel Servais is the Honorary President of the International Society for Labour Law and Social Security and visiting professor of the University of Gerona. He served with the International Society for Labour & Social Security Law (ISL&SSL) in Geneva from 1972 to 2005, where he inter alia held positions as Deputy Regional Director for Asia and the Pacific, Research Coordinator at the

International Institute for Labour Studies, and Director of Operations at the ILO Regional Office for Arab States. He is the author of numerous books and articles in the field of international and comparative labour law and industrial relations.

Tonia Novitz (United Kingdom)

Member of the Advisory Board

Tonia Novitz is Professor of Labour Law at the University of Bristol. Her research interests focus predominantly on labour law, international and EU trade law and the protection of human rights. She is a graduate of the University of Canterbury (Christchurch, New Zealand) and Balliol College (Oxford). Tonia Novitz has held fellowships at the International Institute for Labour Studies (Geneva), the European

University Institute (Florence), the University of Melbourne and the University of Auckland. She has been a professor at Bristol University since 2008. She is also a member of the executive committee of the Institute of Employment Rights and an honorary member of Old Square Chambers. She is writing on 'gig economy' issues with her colleagues at Bristol, Katie Bales and Alan Bogg. See "'Voice" and "Choice" in Modern Working Practices: Problems With the Taylor Review' (2018) 47(1) Industrial Law Journal 46–75.



Leszek Mitrus (Poland)

Leszek Mitrus is professor of labour law at the Jagiellonian University in Kraków (Poland). Author of about 120 publications on Polish, European and international labour law and social security law. Among these publications are books on free movement of workers, EU directives on employment contract and influence of European labour law on Polish legal system, as well as termination with notice of an employment contract due to

reasons concerning and employee. Co – author of commentaries to the Treaty on the functioning of the European Union, the Charter of Fundamental Rights of the European Union and the Polish Labour Code. He is the member of the European Labour Law Network, a member of the editorial board of quarterly *Monitor Prawa Pracy (Labour Law Monitor)*. From September 2016 to March 2018 he has been a member of the Commission for Codification of the Labour Law.



Lejo Sibbel (The Netherlands)

Lejo Sibbel has been the Specialist on International Labour Standards and Labour Law in the Moscow Office of the International Labour Organization (ILO) since November 2015. In this function his main responsibility is to promote improved conformity of national legislative frameworks, and the application thereof, with the international labour standards of the ILO. He is a human rights expert specialized in the field of labour rights,

with twenty-five years international experience, of which 20 years with the United Nations/ILO. He has lived and worked in different countries in Asia, Europe and the Middle East.



Carla Spinelli (Italy)

Carla Spinelli, Ph.D, is Associate Professor at the Department of Law, University Aldo Moro of Bari, where she teaches "Labour law" and "EU social law". She has been visiting professor at Lyon 2 University and participated in several Erasmus teaching staff mobility programmes in Belgium and Spain. She is member of the scientific committee of two Italian Labour law journal (*Diritti, lavori, mercati; Rivista giuridica del lavoro*). She participates in a number of

research projects on Labour law and European labour law. She has been a speaker at many scientific conferences, both national and international. She is the author of many articles and essays published in Italian and in English in national and international collective volumes and journals. She published two books, one on public management in 2012, *Il datore di lavoro pubblico* and the other on smart working in 2018, *Tecnologie digitali e lavoro agile*. She is co-editor of two books *El empleo publico. Puntos criticos en los ordenamientos italiano y español* (Thomson Reuters-ARANZADI, 2018) and *Los derechos fundamentales en el empleo publico* (Editorial Comares 2021). Her main research interests are currently focused on digital economy and transformations of work; antidiscrimination law and reasonable accommodation for people with disabilities; work-life balance; labour law in the public sector.

Merle Erikson (Estonia)

Merle Erikson is professor of labour law at the University of Tartu. Her main areas of study and teaching are Estonian labour law, international labour law and the European Union social policy and labour law. Merle Erikson has authored over a hundred publications, which include academic articles, monographs and contributions to edited volumes and participated in dozens of international and Estonian research projects..



Colin Fenwick (Australia)

Colin Fenwick is Head of the Labour Law and Reform Unit at the International Labour Office in Geneva, Switzerland. Before joining the ILO he was an Associate Professor at Melbourne Law School. Colin's research explores the effects of labour law as a policy instrument for labour market regulation, with a particular focus on developing economies. He has edited several books on this topic, and published in leading law journals.



Emanuele Menegatti (Italy)

Emanuele Menegatti is Professor of Labour Law and Dean of the School of Economics and Management at the University of Bologna. He has published two books and numerous articles in the field of comparative, EU and Italian labour law. He is the co-editor of the books Labour Law and Industrial Relations in Italy and The Sources of Labour Law, both published with Wolters Kluwer. He is the editor-in-chief of the Italian labour law e-journal.
